**Stud Dog Class:** For Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of the Stud Dog need not be the owner of the Get. Get considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the Standard for its breed. An Entry Fee of \$26.00 total for Stud Dog and Get if all are entered in another class. An Entry Fee of \$26.00 will be charged for each dog not individually entered in one of the Regular Classes, Best of Breed (Variety) Competition or some Non-Regular class other than Stud Dog. Stud Dog need not be in show trim.

**Brood Bitch Class:** Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

As the judge's decision in the Stud Dog and Brood Bitch Classes will be based upon the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed (Variety) by virtue of having won this class.

**Brace Class:** (two identical ownership) will require a fee of \$25.00 for a Brace as a unit. The dogs comprising a Brace must be named at the time of entry. If a dog which is to be part of a brace is not entered in another class, it must be entered for "Brace Class", full particulars must be given for each dog on individual regular forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for additional classes "Brace Class". If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No. 1", etc.

**"Clip":** A Poodle under 12 months may be shown in the "Puppy" clip. In all regular classes, poodles 12 months or over must be shown in the "English Saddle" or "Continental" clip. In the Stud Dog and Brood Bitch Classes and in a non-competitive Parade of Champions, Poodles may be shown in the "Sporting" Clip. A Poodle shown in any other type of clip shall be disqualified.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

- (Variety) if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniels (Black, ASCOB, Parti-color), Beagles (not exceeding 13 in.; over 13 in. but not exceeding 15 in.), Dachshunds (Longhaired, Smooth, Wirehaired), Bull Terriers (Colored, White), Manchester Terriers (Standard, Toy), Chihuahuas (Smooth Coat, Long Coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (Toy, Miniature, Standard), Collies (Rough, Smooth).
- The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list, if the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on the entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 14, Section 3.)

**ENTRY FEE:** \$28.00 (including \$.50 AKC recording fee & \$3.00 AKC Event Service Fee) for the first entry of a dog and \$20.00 for each additional entry of the same dog. \$20.00 for Bred-By-Exhibitor Classes. Puppy Classes (6-9 & 9-12 mos) are \$20.00 and Parade of Champions, \$20.00.

**CLOSING DATE** for entries 12:00 NOON, Wednesday, November 25, 2009 (at Show Secretary's Office) After Which Time Entries Cannot Be Accepted, Cancelled or Substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

**THE SHOW** will be open from 8:00 A.M. to 6:00 P.M.

**An AKC RECORDING FEE OF \$.50 & an AKC Event Service Fee of \$3.00** will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee and Service Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). All Recording Fees are paid to the American Kennel Club.

**RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a **\$20.00 collection fee** to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

**TELEGRAPH, TELEPHONE and UNSIGNED ENTRIES CANNOT BE ACCEPTED.**

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS** without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE.**

**ENTRIES RECEIVED WITHOUT FEES** will not be accepted.

**ACKNOWLEDGEMENT OF ENTRIES** will be made as soon as possible with tickets and/or identification cards. The person accompanying a dog must show tickets of admission and identification before the dog will be received. **SHOULD SUCH ACKNOWLEDGEMENT NOT BE RECEIVED BY THE EXHIBITOR** within a reasonable time, please notify the Show Secretary at (610) 376-1880.

**MAKE ALL CHECKS AND MONEY ORDERS PAYABLE TO** Poodle Club of Lehigh Valley, Inc. Please mail checks or money orders with entries. Show Secretary assumes no responsibility for cash sent through the mail.

**ALL CREDIT CARD ENTRIES, REGARDLESS OF METHOD SUBMITTED,** are processed through the Fax program and will be charged a \$4.00 per dog per show processing fee.

**CANADIAN EXHIBITORS** make fees payable in **U.S. FUNDS.**

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made.

**ERRORS ON ENTRY BLANKS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**NO REFUND FOR DUPLICATE ENTRIES.** We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

**CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.**

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the show secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged or when in the exercising ring. No space for unentered dogs at this show.

**CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the breed is over.

**THE SHOW COMMITTEE/SHOW SECRETARY** will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

**Since bitches in season** are not permitted to compete in Obedience Trials, the Club will refund all but five dollars of the entry fee for bitches unable to compete for that reason. The Show Secretary must be notified of such claim for refund at the show or by letter postmarked DECEMBER 14, 2007 or earlier.

**NOTE:** "Effective for all shows held on or after July 1, 1980, dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary prior to the start of judging of the show."

**DECLINATION OF ENTRIES.** The Poodle Club of Lehigh Valley, Inc. may decline any entries for cause and may refuse to receive or may remove dogs on account of disease, viciousness or other causes and no one shall have any claim or recourse against the Poodle Club of Lehigh Valley, Inc. or any official thereof.

Effective May 1, 2006 an administrative fee of \$2.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
