**NOTE: There will be NO Novice Classes or Team Class offered at this show.**

**Brace Class.** The entry fee for a Brace as a UNIT is \$25. The dogs comprising a Brace MUST be named at time of entry. If a dog which is to be part of a Brace is not entered in any of the Regular Classes or for Best of Breed (Variety) Competition, it must be entered for "Brace Class Only", full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes - "Brace Class". A Brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. If more than one Brace is entered by the identical owner the dogs comprising EACH Brace must be so designated, "Brace No 1", "Brace No 2", etc. Brace as an additional entry - \$20.00 for the unit.

**NEW BRED-BY-EXHIBITOR RULES**

Competition is offered for dogs & bitches entered and exhibited in the bred-by-exhibitor classes to compete for Best of Breed/Variety Bred-By-Exhibitor through Best in Show Bred-By-Exhibitor. A bred-by-exhibitor dog/bitch that wins Best of Breed or Best of Winners in the regular conformation classes are automatically Best of Breed/Variety Bred-By-Exhibitor.

AKC handler restrictions apply to all Bred-By-Exhibitor competitions.

Competition for Best Bred By in Breed/Variety to be held after Best of Breed/Variety competition. Competition for Best Bred By in Show to be held after Best-in-Show.

**Amateur-Owner-Handler** - For dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog and is limited to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler.

All dogs, 7 years or older, who are AKC Champions, or have earned Obedience, Agility, Tracking, or Hunting, WD, WDX or other AKC Titles are eligible for this noncompetitive title parade. A dog entered in this Parade of Titleholders may NOT enter regular breed classes at this show. Each entrant will receive a rosette. Everyone is encouraged to come to the Parade prepared to "showcase" their dog's area of excellence (for instance, bring an obedience dumbbell, tracking harness, bumper or bird wing).

A (50 word or less) description of the dogs career is to be provided to the Show Chairman no less than 48 hours in advance of the scheduled class. The Show Chairman reserves the right to edit the provided copy.

**A ROSETTE WILL BE PRESENTED TO EACH ENTRANT WITH  
NAME IMPRINTED ON IT.**

In addition to the Parade of Champions there is in EACH Breed or Variety of Breed a Veterans Class. This Class is for all eligible dogs seven years of age or older. The winners will be eligible for Best of Breed or Variety. (Sexes divided). There will be NO classes for EXHIBITION ONLY.

⌋ NOTICE TO EXHIBITORS ⌋

**DUE TO SPACE LIMITATIONS ENTRIES WILL BE LIMITED TO 1000 DOGS. CLOSING DATE** for entries 12:00 Noon, Wednesday, December 23, 2009 (at Superintendent's Office) after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

**THE SHOW AND OBEDIENCE TRIAL** will be open from 7:00 A.M. to 10:00 P.M. (Each Day).

**An AKC RECORDING FEE of \$.50 and an AKC Event Service Fee of \$3.00** will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee and Service Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). An AKC Recording Fee of \$3.00 will be required for each entry in any Licensed or Member Club Rally Trial. If a dog is entered in more than one class in a Rally event, the AKC Recording Fee is to be collected on each of the entries of that dog. (AKC Rally Regulations, Chapter 1, Section 3). All Recording Fees are paid to the American Kennel Club.

**RETURNED CHECKS** do not constitute a valid entry fee. The Superintendent will add a **\$20.00 collection fee** to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

**TELEGRAPH, TELEPHONE AND UNSIGNED ENTRIES CANNOT BE ACCEPTED.**

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS** without the Agree-ment and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE.**

**CANADIAN EXHIBITORS** make fees payable in **U.S. FUNDS.**

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made.

**ERRORS ON ENTRY BLANKS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**NO REFUND FOR DUPLICATE ENTRIES.** We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

**CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.**

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The Show-giving club and the Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent to be advised at once. The Superintendent and Show-giving Club may disclaim any liability for cash prizes after the judging of the breed is over.

**THE SHOW COMMITTEE/SUPERINTENDENT** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

**ANNUAL JANUARY SPECIALTY SHOW  
RULES FOR COCKER SPANIEL FUTURITY STAKE**

JUDGE: Clifford Steele

**Breeders of entries for the futurity MUST BE American Spaniel Club, Inc. ("ASC") members through all steps of the futurity (have current annual dues paid).** Owners (if other than the breeder) of entries are not required to be ASC members.

Nominations and enrollments shall be sent to the Futurity Chairman **only on the forms issued by ASC**. You may photocopy the forms. The forms state the required payment and information. Incomplete forms will be returned. *Fees must be paid in U.S. funds. (Checks drawn on U.S. banks and U.S. Money Orders only). There will be no refunds. Checks on Foreign Banks for U.S. funds are not acceptable, and if sent will be returned along with the Futurity Form.*

The steps which must be taken to Futurity nominate are as follows:

1. **Bitch Nomination.** The dam of the litter must be owned or leased by an ASC member(s). The dam must be properly nominated prior to whelping (between January 1 and June 30 inclusive). Only puppies from nominated bitches, whelped after date of nomination, are eligible. The nomination envelope must bear a post office cancellation stamp with a date prior to the whelping date. **Postage Meter is not valid.** A fee of \$10.00 for each bitch nominated must accompany the form, in accordance with the instructions stated on the form. If the bitch's due date is such that she may whelp in either the January or July Futurity, you should nominate her for both. **NOTE: Both nominated bitch and sire of the litter MUST be at least two years of age at time of breeding. When nominating a bitch, photocopies of the individual AKC Registration Certificates for both nominated bitch and sire of the litter must be included with the Nomination Form.** If the bitch is leased, send photocopies of the AKC Registration and Lease Form filed with the AKC.
2. **Puppy Enrollment.** Enrollments of any puppies that the breeder(s) or owner(s) wishes to enroll must be made on or before **November 1**. Enrollments must be made on the form issued by ASC and a payment of \$10.00 per puppy is required. The form will state the complete requirements, but generally, the name of the puppy, the name of sire and dam, date of birth, sex, variety and individual AKC Registration Number must be given. Canadian-bred or Mexican-bred puppies may provide a Canadian or Mexican Registration Number, if an AKC Number is not yet obtained. **Late Enrollment:** You may make a late puppy enrollment for a fee of \$25.00 per puppy, provided all other requirements are met. **LATE ENROLLMENTS DO NOT GO BY POSTMARK. THEY MUST BE RECEIVED BY THE CHAIRMAN BY DECEMBER 1.**
3. **Entry.** Entries shall be made in the name of the OWNER(S) who need not be a member of ASC. A final payment of \$15.00 for each puppy to be shown shall be made to the Superintendent of the show before the closing of entries for the January Annual Flushing Spaniel Show, at which time the Name, AKC Number, Date of birth, Breeding, Sex and Variety of each puppy must be given on the regular, AKC approved entry blank, together with the payment of the regular entry fee. Each puppy shall be entered in one of the regular classes and, in addition, the entry blank must also be designated "Futurity Stake". The BREEDER(S) of the puppy MUST STILL BE A CURRENT MEMBER OF ASC. The ASC is not responsible for any errors made on the blank and no refunds will be made by ASC.

The money received by ASC from the nomination of bitches shall be divided as follows: 40% for the expenses of the Futurity Stake, 10% for the Best Puppy in Futurity (50% of this will be awarded to the puppy's owner, 50% to the breeder), 5% for Best Opposite Sex to Best in Futurity Puppy (50% of this will be awarded to the puppy's owner, 50% to the breeder), 10% for Best Puppy in Each Variety, 5% for Best Opposite Sex to Best in Each Variety.

The money received by ASC from the puppy enrollments and the final payment in each sex, each age group, AND each variety shall be divided as follows: 40% of the total for expenses for the Futurity Stake, and the remaining shall be divided among each sex, each age group, and among each Variety as follows: 25% to first, 20% to second, 10% to third, and 5% to fourth.

The judging in each sex and Variety shall be as follows: 6 to 9 months; 9 months and over but not exceeding the age limitations of the Futurity. Each sex, each age group in each variety shall be judged separately. Following the judging of each age and sex group of each variety for best in each group above, the six shall be judged, first for best of each respective Variety, and best opposite sex to each Variety, and from the final three shall be selected the best puppy in the Futurity. Any dog of opposite sex to Best in Futurity, if undefeated within their Variety shall compete for Best Opposite Sex to Best in Futurity.
