ROUTES TO THE EVENT SITE

From NYC & South:

Take the Taconic State Pkwy North to Underhill Avenue Exit. Turn right onto Underhill Avenue. Follow Underhill Avenue for 1.8 miles. Turn right to stay on Underhill Avenue. In another 0.2 miles turn right onto Hanover Street. In 0.3 miles, turn left onto Moserman Avenue. The Grange fairgrounds will be on your right.

From Putnam County and North:

Take the Taconic Parkway south to the Underhill Avenue Exit. Turn left onto Underhill Avenue and follow directions above.

From Connecticut:

Follow I-84 West to Exit 16 South for the Taconic Parkway South. Take the Taconic Parkway to the Underhill Avenue exit and follow directions above.

From NJ and Rockland County:

Tappan Zee Bridge to Exit 8A for Saw Mill Parkway North. Follow the Saw Mill Parkway to Exit 26 for the Taconic Parkway. Take the Taconic Parkway to the Underhill Avenue exit and follow directions above.

FOLLOW THE DOG SHOW ARROWS

Follow I-684 to Exit 6 for NY-35.

From exit follow Rte 35 (West) to downtown Yorktown Heights.

Turn left onto Rte. 118 and follow to intersection with Rte. 202 and Hanover Street.

Turn left onto Hanover Street.

Follow Hanover Street past firehouse. At first traffic light after firehouse, turn left onto Moserman Avenue. Grange fairgrounds on right.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent to be advised at once. The Superintendent and Show-giving Club may disclaim any liability for cash prizes after the judging of the breed is over.

THE SHOW COMMITTEE/SUPERINTENDENT will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

No crates will be allowed under the show tents.
