**COVID Protocols for May 8-9, 2021 at the Lehigh Valley Hotel:**

- All persons on the show grounds must sign a COVID waiver form. All attendees will be given a wristband afterward. Wristband may not be removed while on the show grounds.
- SHOW AND GO. NO GROOMING TENT. All grooming must be completed at home or at your vehicle. Pop up tents will be permitted by your vehicle or where instructed by grounds personal. Grooming areas to be social distanced. Due to limited parking grooming space may be up to the footprint of your vehicle(s).
- Pop up tents/Grooming set ups may NOT be within 40 feet of a ring.
- Wristband must be shown to obtain your armband
- Catalogs will be available online. None will be offered for sale. None will be available ringside.
- Masks will be mandatory on the Show Grounds. Inside and outside the rings and while grooming at your vehicle.
- Social distancing will be enforced.
- Due to restricted occupancy on the grounds any exhibitor that has completed judging for the day maybe asked to leave the ring area.

These COVID Rules are subject to change with any changes or additions to adhere to the current State and Federal Guidelines as they evolve. Failure to adhere to the show's protocols may result in removal from the grounds and/or a AKC Bench Hearing.

**Health Acknowledgment & Liability Waiver**

I \_\_\_\_\_ am aware of the potential spread of COVID-19 that could result in severe illness and potential death. My presence at this event proves I voluntarily accept this risk and accept sole responsibility for any injury to myself or my children (including, but not limited to, illness, damage, loss, claim, liability, or expense of any kind) that may be experienced or incurred in connection with attendance at this event.

I understand that the risk of becoming exposed to or infected by COVID-19 at this event may result from the actions, omissions, or negligence of myself and others, including, but not limited to the Central New Jersey Hound Association, show staff, employees, volunteers, participants, attendees, and their families. I hereby release, covenant not to sue, discharge, and hold Central New Jersey Hound Association & Rau Dog Shows their agents, officers, directors, employees, volunteers, attendees or other participants from any claims.

**SOCIAL DISTANCING**

I will, to the best of my ability, practice proper social distancing as recommended by the State of PA guidelines & directives, as well as practice good hygiene (hand washing, use of hand sanitizer, wearing of a mask if and when required, etc.) and follow other health recommendations. I will not sit in groups closer than 6 feet and will practice social distancing at all times.

**HEALTH REPORTING**

- I have not experienced new or worsening symptoms of possible COVID-19 in the last 14 days, including cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, feeling feverish or a temperature greater than 100° F. I have not had close contact with a person symptomatic or confirmed to have COVID-19 in the last 14 days.
- I have not been diagnosed with COVID-19 within the last 14 days. If I have been infected by COVID-19 at any time, I have been medically released to return to normal activities.
- If I develop a fever and symptoms, such as a cough or difficulty breathing, or if I am diagnosed with COVID-19 within 14 days of this event, I will report this information to the Central New Jersey Hound Association.
- Should symptoms develop during the event, I will report symptoms to the Central New Jersey Hound Association Show Chairs and immediately leave the event.

Any person violating the waiver rules regarding masks, distancing or wrist band propriety may be subject to prosecution under the Commonwealth of Pennsylvania COVID 19 Executive Order, as well as AKC misconduct complaint, either of which may result in immediate expulsion from the grounds.
