## DIRECTIONS TO THE EVENT SITE

Right on Route 6 to traffic light at Route 301. Left on Route 301 and continue over causeway across reservoir. Immediately at the end of the causeway make a right on Gipsy Trail Road and continue to park entrance on the right.

**From all Points North/South - Taconic State Parkway:** Take Peekskill Hollow Road Exit right at the bottom of the ramp onto Peekskill Hollow Road. Continue to the end and turn right onto Route 301. Continue on Route 301 until you see the causeway over the reservoir (slight curve to the right). Just before the causeway, Gipsy Trail Road will be on the left. Take Gipsy Trail Road will be on the left. Take Gipsy Trail Road to entrance to park on the right.

The Putnam County Department of Health requires that all dogs be vaccinated against rabies. Proof of inoculation must be presented if requested.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent to be advised at once. The following plan is designated at this time for HRVHA Dog Shows and subject to change. Failure to comply could subject the individual to being removed from the grounds and/or disciplinary action in accordance with AKCs Dealing with Misconduct booklet.

- 1) NO SPECTATORS ARE ALLOWED. These shows are closed to the general public. This is a SHOW AND GO SHOW. All attendees(officials, judges, stewards, exhibitors and all workers) are required to follow state, local and facility guidelines in effect at the time of the event.
- 2) EXPOSURE TO COVID-19. If you have been recently in the presence of a person who has either tested positive for COVID-19 or has symptoms(cough, sneezing, fever) please stay home. If you are ill, feel unwell, coughing, sneezing, or running a temperature, please stay home. All attendees are expected to adhere to social distancing guidelines and are required to wear a face covering. MASKS ARE REQUIRED UNDER THE TENTS, RINGS AND VENDOR AREAS.
- 3) Please remember to bring personal face coverings, hand sanitizer, cleaning wipes, etc. for your own personal use.
- 4) Exhibitor and all participants should SANITIZE hands as frequently as possible.
