DIRECTIONS TO THE SHOW

Charlotte-Douglas International Airport (CLT)

Take I-85 S. to US-321 N. to I-40 W. Take I-240 W. to exit 3B and drive to Resort Drive. Follow the road to registration.

From the North

Head south on I26 E. Take the exit onto I240 W I26 E US19 S US23 S toward W. Asheville. Continue on US19 S US23 S US74 ALT W. Turn right onto Regent Park Blvd. Turn left to stay on Regent Park Blvd. Continue onto Expo Dr. Turn left onto Resort Dr. The hotel will be on your right.

From the South

Head northwest on I26 W. Follow signs for I26 W Asheville I240. Take Exit 3A and merge onto US19 S US23 S US74 ALT W. Turn right onto Regent Park Blvd. Turn left to stay on Regent Park Blvd. Continue onto Expo Dr. Turn left onto Resort Dr. The hotel will be on your right.

From the East

Merge onto I40 W. Take Exit 53B for I240 W. US74A W. toward Asheville. Continue on I240 W. Keep left at the fork to continue on US19 S US23 S US74 ALT W. Turn right onto Regent Park Blvd. Continue onto Expo Dr. Turn left onto Resort Dr. The hotel will be on your right.

Exhibitors are prohibited from taking photos during the formal "win" shooting, including "over the shoulder" cell phone photos.

***Candid photography at this event will be for personal use only and NOT be advertised for retail sale

DOGS MAY ARRIVE any time prior to their scheduled time of judging. DOGS NOT REQUIRED for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that class is over, and the Show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the class is over. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Effective January 1, 2009 - Refund and Cash award checks are void after 180 days and will NOT be re-issued.
