

#### **BEST OF BREED COMPETITION**

#### Non-Regular Classes Involving Single Dog Entries

Veteran: For Dogs/Bitches 7 years of age and over on the day of the show. Divided by sex.

#### Bred-by-Exhibitor (BBE) Class eligibility

- All dogs entered in the Bred by Exhibitor Class must be individually registered with the AKC.
- The persons handling the dog must be a breeder of record of the dog and an owner of record of the dog.
- To exhibit in this class, family members must be a breeder and owner of record.

#### Amateur-Owner-Handler

For dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog and is limited to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler.

#### **Award of Merits**

At the discretion of the judge may award based on the number of dogs entered in Best of Breed Competition will be: 2-10 Entries - 1 Award, 11-20 Entries - 2 Awards, 21-30 Entries - 3 Awards.

#### **DIRECTIONS TO THE SHOW SITE**

- **From Route 1 Southbound -** Take Route 1 Exit. Exit onto Main Street and go 1/4 mile to the traffic light onto Route 514 East (Woodbridge Avenue). Turn right at the Sheraton Hotel into Raritan Center. Follow the signs to the Expo Center.
- **From Route 1 Northbound -** After crossing the Raritan River Bridge, get into the right lane. After passing "Open Round Honda" take the third right hand exit onto Route 514 East (Woodbridge Avenue). Follow Woodbridge Avenue for 3 to 4 miles. Make a right at the Sheraton Hotel into Raritan Center. Follow the signs to the Expo Center.
- From Route I-287 South Follow Route I-287 South to the Bonhamtown ONLY, Route 514 West Exit. (This exit is just after the NJ Turnpike Exit). Follow Route 514 West to the first exit ramp marked Raritan Center. Follow the signs to the Expo Center.
- From the NJ Turnpike Follow the NJ Turnpike to Exit 10. Pay the toll, to the right, follow Route 514 West to Raritan Center. Take the first exit marked Raritan Center and follow the signs to the Expo Center.

AN AKC RECORDING FEE OF 50¢ & AKC Event Service Fee of \$3.00 for the first entry of a dog & a \$3.50 service fee each additional entry of the same dog in an event will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the recording Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). All Recording Fees are paid to the American Kennel Club.

RETURNED CHECKS do not constitute a valid entry fee. The Superintendent will add a collection fee of \$20.00 to the amount of each returned check.

**ONLINE ENTRIES** for events produced by Rau Dog Shows can be made at <u>raudog.co/entries</u> **TELEGRAPH**, and **UNSIGNED ENTRIES CANNOT BE ACCEPTED**.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

NO REFUND FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. DOGS NOT REQUIRED for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that class is over, and the Show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the class is over.

EFFECTIVE MAY 1, 2006 an administrative fee of \$2.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.

#### INSTRUCTIONS

- (Variety) if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety
  you are entering, i.e., Cocker Spaniels (Black, ASCOB, Parti-color), Beagles (not exceeding 13 in.; over 13 in. but not exceeding
  15 in.), Dachshunds (Longhaired, Smooth, Wirehaired), Bull Terriers (Colored, White), Manchester Terriers (Standard, Toy),
  Chihuahuas (Smooth Coat, Long Coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (Toy,
  Miniature, Standard), Collies (Rough, Smooth).
- 2. The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is Limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list, if the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on the entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 14, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All-American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed etrants.
