**DIRECTIONS TO THE EVENT SITE**

**From all Points East/West:** Take I-84 to Exit 19 (Route 312) toward Carmel, NY. Continue on Route 312 to traffic light at Route 52. Right at the light to Route 6. Right on Route 6 to traffic light at Route 301. Left on Route 301 and continue over causeway across reservoir. Immediately at the end of the causeway make a right on Gipsy Trail Road and continue to park entrance on the right.

**From all Points North/South - Taconic State Parkway:** Take Peekskill Hollow Road Exit right at the bottom of the ramp onto Peekskill Hollow Road. Continue to the end and turn right onto Route 301. Continue on Route 301 until you see the causeway over the reservoir (slight curve to the right). Just before the causeway, Gipsy Trail Road will be on the left. Take Gipsy Trail Road will be on the left. Take Gipsy Trail Road to entrance to park on the right.
