At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: AMERICAN WATER SPANIEL, BOYKIN SPANIEL, ENGLISH SPRINGER SPANIEL, FIELD SPANIEL, LAGOTTO ROMAGNOLO (thru 4/2/24), NS DUCK TOLLING RETRIEVER, WELSH SPRINGER SPANIEL, GRAND BASSET GRIFFON VENDEEN, WHIPPET, GERMAN PINSCHER, STANDARD SCHNAUZERS, AMERICAN STAFFORDSHIRE, IRISH TERRIERS, MINI BULL TERRIER (Ground/Table), SOFT COATED WHEATEN TERRIER, STAFFORDSHIRE BULL TERRIER, FINNISH SPITZ, AUSTRALIAN CATTLE DOG (eff. 1/31/24), ENTLEBUCHER MOUNTAIN DOG, FINNISH LAPPHUND, ICELANDIC SHEEPDOGS, MUDI (or Table), NORWEGIAN BUHUND, POLISH LOWLAND SHEEPDOG, PULI (or Table) (eff. 1/31/24), SPANISH WATER DOG, BASSET FAUVE DE BRETAGNE (Misc.), NORRBOTTENSPETS (Misc.)

The following breeds must be judged on a ramp through all levels of conformation competition: CLUMBER SPANIEL, LAGOTTO ROMAGNOLO (eff. 4/3/24), SUSSEX SPANIEL, BASSET HOUND, CIRNECO DELL'ETNA, KERRY BLUE TERRIER, BULLDOGS, CHINESE SHAR-PEI, CHOW CHOW, KEESHONDEN

This extends to all conformation competition at AKC conformationdog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breed

NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a celebration of the dedication and enthusiasm of owner-handlers and is open to purebred dogs that are at least six months of age. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.

- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
