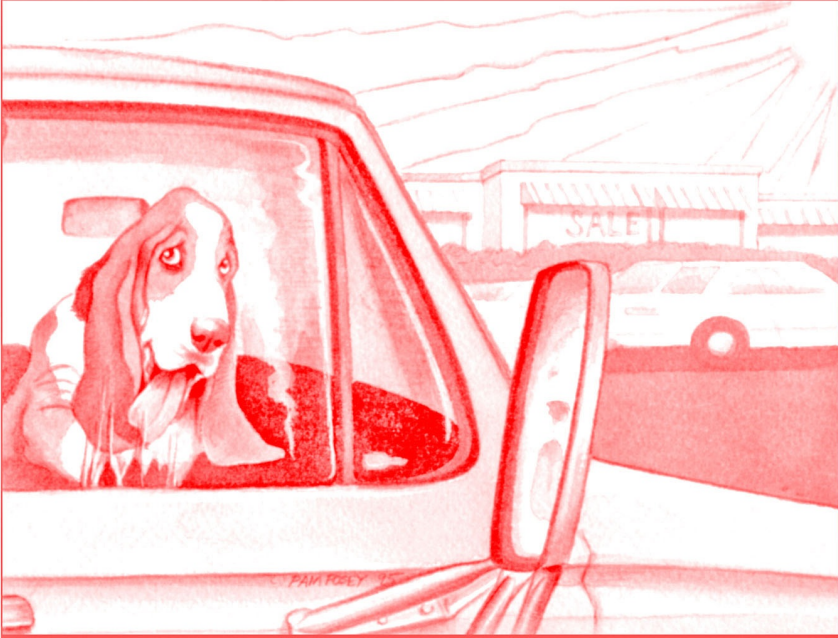
**SURRENDER OF IDENTIFICATION CARD** must be made to the check clerk for removing dogs from the show, if requested.
