DIRECTIONS TO THE SHOW

From PA Turnpike: Follow I-476 S and I-276 E, continue into New Jersey on NJ Turnpike. Take the US-130 N exit toward Bordentown (0.7mi) from New Jersey Turnpike.

From US-130: take right onto Florence Columbus Rd (1.8mi), continue onto Columbus Rd (1.3mi), and turn right onto Petticoat Bridge Rd (1.8mi) turn left onto Jacksonville Jobstown Rd (1.1 mi) Destination on left.

Local roads Rt. 70 and Rt. 38, travel east to Rt. 206 and travel north to the site. Site is at the corner of Rt. 206 and Jacksonville/Jobstown Road.

From South: Take I-295 N to NJ-38 E in Mount Laurel. Take Exit 40A from I-295N Follow NJ-38 E and US-206 N to Jacksonville-Jobstown Road in Mansfield.

★ NOTICE TO EXHIBITORS ★

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the show secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring. No space for unentered dogs at this show.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the breed is over.

THE SHOW COMMITTEE/SHOW SUPERINTENDENT will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

NOTE: "Effective for all shows held on or after July 1, 1980, dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent prior to the start of judging of the show."

DECLINATION OF ENTRIES. The William Penn Poodle Club may decline any entries for cause and may refuse to receive or may remove dogs on account of disease, viciousness or other causes and no one shall have any claim or recourse against the William Penn Poodle Club or any official thereof.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Effective May 1, 2006 an administrative fee of \$2.00 will be withheld from all refunds for entries cancelled prior to the closing of entries. **Effective January 1, 2009** - Refund and Cash award checks are void after 180 days and will NOT be re-issued.
